General Conditions Kuehne+Nagel NV (Business Unit Road Logistics)

General:

- 1. Kuehne+Nagel NV (Business Unit Road Logistics) (hereafter also referred to as: "K+N") acts exclusively as forwarder. These terms and conditions apply to all our activities and agreements, as well as the General Belgian Forwarding Terms and Conditions 2005, published in the appendix to the Belgian Official Gazette dated 24th June 2005 under no. 0090237. In so far as K+N undertakes with regard to a principal to carry out its own freight transport, the transport operations are carried out on the basis of the Belgian General Terms and Conditions of Road Transport of Febetra, in addition to these general terms and conditions. The text of these conditions will be sent to you free of charge upon first request. In addition to our warehousing and contract logistics services, the general logistics conditions of Febetra will be applied.
- 2. As soon as an order has been given, it is automatically agreed that the principal has accepted the offer as well as the aforementioned terms and conditions.
- 3. In the event of contradictions between the Belgian General Terms and Conditions of Road Transport and the General Terms and Conditions of K+N, the arrangement contained in the General Terms and Conditions of K+N will prevail.

Placing the order:

- The orders should be issued in writing (e-mail) or electronically (EDI, Internet).
 - Export shipments and shipments within the Benelux < 2.500 kg and/or 2 loading metres (hereafter also referred to as : groupage) : one working day before collection and latest 1600 hours.
 - Import groupage shipments : one working day before collection and latest 1400 hours.
 - Export shipments and shipments within the Benelux > 2.500 kg and/or 2 loading metres (hereafter also referred to as: "LTL/FTL"): one working day before collection and latest 1300 hours.
 - Import LTL/FTL shipments: one working day before collection and latest 1100 hrs.
- 5. For shipments cancelled within 1 working day before collection, and after 1200 hours, 70 % of the agreed rate will be charged. For shipments cancelled on the day of collection, 100% of the agreed rate will be charged.
- 6. Charges for a later adjustment of the delivery terms (incoterms) will be € 25.00 per shipment.
- Changes in composition of the shipment are only possible one working day before pick-up before 1730 hours or on the day of the pick-up, subject to written mutual agreement.
- 8. K+N has decided to handle the distribution paperless. In the event documents are required for a particular shipment, these documents must be firmly attached to the shipment in a clear document holder in a visible place. The paperless handling of goods does not apply to goods under customs control or goods on which the European Agreement Concerning the International Carriage of Dangerous Goods by Road (ADR) apply.
- 9. The client is responsible for stating the correct dimensions (length, width, height) and weights. If the transport order does not include full dimensions, K+N will charge a minimum of 0.4 loading metres per pallet. If incorrect dimensions are stated, an administrative cost of €15.00 per shipment will be charged, as well as a settlement according to the corrected dimensions.
- 10. Shipments should have visible and clearly readable name and address of the consignee.
- 11. Register shipment (by telephone/e-mail) at the receiver: € 9.75 per shipment. This has to be stated explicitly with every shipment. Standard transit times for these shipments may differ in these cases.
- 12. Booking in service via an external customer portal: € 15.00 per shipment.
- 13. Manual orders (not issued electronically via EDI or Internet): € 4.95 per shipment.
- 14. Should the number of colli found exceed the initial number of colli ordered, than this will lead to longer transit times and possibly extra costs. These extra costs will be charged.

Goods:

- 15. The goods to be shipped or transported are non-hazardous merchant goods that are properly packaged, goods that are not properly packaged, K+N reserves the right to refuse these goods. K+N is never liable for damage as a result of a (hidden) defect in the packaging.
- 16. The maximum weight per carton/ package may be 25 kg. If a consignment consists of more than 5 cartons/packages, the goods must be palletised.
- 17. Instructions for the transport of dangerous goods must be given in writing or by electronic means, with all the necessary information on the documentation to carry out the transport within the framework of the ADR scheme (in particular sender's declarations and UN numbers). The goods must be packed in accordance with the legislation in force. K+N reserves the right to refuse to accept goods that are not properly packed
- For arranging transportation of dangerous goods (ADR) a surcharge applies depending on the country of destination and/or origin. ADR surcharges:
 - a. ADR shipments within the BENELUX: 10% on the rates agreed upon for entire shipment with a minimum of € 10.00 and a maximum of € 100.00 per shipment.
 - ADR shipments to Greece and Cyprus: on request.
 - c. ADR shipments to Denmark (pc 1000 up until 4900): 10% on the rates agreed upon with a minimum of € 75.00 and a maximum of € 250.00 per shipment.
 - d. ADR shipments to Finland, Norway or Sweden: 10% on the rates agreed upon with a minimum of € 110.00 and a maximum of € 250.00 per shipment.
 - e. ADR shipments to remaining European destinations: 10% on the rates agreed upon with a minimum of € 25.00 and a maximum of € 250.00 per shipment.
 - f. Previous articles do not apply to the transport of ADR Class 1, Class 2 (T, TF, TC, TO, TFC, TOC), Class 4.1 (D, DT, SR2), Class 5.2 (P2), Class 6.2 and Class 7 and UN 1790. Assignments for this are only possible on request.
- 19. For LTL/FTL pick-ups/deliveries with a tail lift outside Belgium, a surcharge will be applicable of min. € 75.00 per shipment. Standard transit times for these shipments may differ.
- 20. Maximum weight for shipments to be picked up/delivered with tail lift is 1,000 kg per collo. For shipments with a gross weight over 430 kg, (un-)loading facilities are mandatory.



 - Any collection costs resulting from exceeding the agreed payment term and/or credit limit are always fully borne by the freight payer. The applied commercial interest – in accordance with the Act of 2 August 2002 on compensation for delay in payment in commercial transactions – is owed from the day after the expiration date of payment.
- 27. Rates are exclusive of VAT. a.
 - Rates are valid for 1 loading- and 1 unloading address. b.
 - The rates are based on a kilogram, pallet- or loading metre quote per shipment and are charged in EURO (€).
 - The volume calculation will be determined as follows:

- 1 euro pallet not stackable (max. 80 x 120 cm)

- Goods with a length of < 240 cm and < 25 kg are calculated by taking the higher of the gross weight or cubic metre weight.
- Goods with a length of > 240 cm and > 25 kg are subject to a length surcharge of 25% over the agreed rate for the entire shipment.
- On an international level, the following aspects are adopted in the rate calculation:
 - Goods will be calculated in kg, cbm or ldm**.
 - For goods with maximum height of 120 cm and explicitly mentioned by the client as being stackable (see article g).
 - The maximum calculation of one column is the minimum calculation of the next.

- For distribution in the Benelux, the following aspects are included in the tariff calculation:

 - For safety reasons ADR goods are always calculated as not stackable on kg, cbm or ldm **.

- Pallets are accepted as stackable if it is possible and permitted to assemble 2 pallets without causing an increased risk of damage during transport and transshipment. This does not apply to shipments in the Benelux.
- For shipments consisting of two pallets or more, a loading metre billing on the basis of pallet spaces (depending on stackability) applies. This means that two stackable euro pallets will be charged on the basis of one pallet space = 0.4 loading metre and two nonstackable pallets for two pallets spaces = 0.8 loading metre.
- Shipments in transit are free of charge on our cross-dock location for 3 working days. After that extra costs will be charged.

- On request K+N facilitates (within Belgium and to/from Germany and the Netherlands) the exchange of euro pallets/"gitter boxes" (hereafter referred to as: "packaging"), on basis of direct change, that is to say, the recipient must return 1 on 1 the same number of packaging as received with the delivery concerned. The returnable packaging must be ready for the exchange. Any additional waiting costs incurred will be charged (see article 40.) In the event of non-exchange, the right to return the relevant packaging will lapse. For administration of exchanging packaging, K+N charges a surcharge of € 2.10 per euro pallet (max.33 units). K+N uses a depreciation of 10% on the balance of the packaging. Prices for returning of gitter boxes are on request only.
- Adjustments to rates/costs due to government decisions and/or caused outside our sphere of influence will be charged. 32.
- The rates charged are based on information with regard to volume and frequency provided. If after expiration of a certain period of time the 33. actual data does not match with information provided, then K+N reserves the right to adjust the rates to the actual situation.
- Proof of Delivery (POD) may be claimed no later than 60 business days after shipping date.
